#### ORDER

In the Government Order read as 1st paper above, Government have laid down guidelines on implementation of the scheme of Special Development Fund for MLAs (MLA-SDF). The guidelines do not permit to undertake works belonging to commercial organisations, private institutions or co-operative institutions with the Fund.

- 2. In partial modification of the guidelines, Government vide GO 2<sup>nd</sup> read above have permitted utilisation of the Fund for the schemes of Dairy Development Societies in accordance with the guidelines of the scheme.
- 3. As per the instructions issued in the Circular 3<sup>rd</sup> and 4<sup>th</sup> read above, Government have permitted utilisation of the Fund for meeting the expenditure on development schemes including procurement of Automatic Milk Collection Units and Milk Testing Machines for Milk/Dairy Co-operatives in the State.
- 4. A few members of the Legislative Assembly have brought to the notice of the Government the need to amend the guidelines of the scheme so that the Fund could be used for construction of buildings for Milk/ Dairy Co-operative Societies also.

- 5. Government having considered the matter in detail order the following amendments to the guidelines of the MLA-SDF scheme.
  - i) to include the 'works related to construction of building for Milk Co-operatives' in item No.29 of Appendix-I of the guidelines issued in the GO 1<sup>st</sup> read above
  - ii) to modify item 2 Appendix-2 of the guidelines as 'works belonging to commercial organisations, private institutions or co-operative institutions other than 'Primary Milk Co-operatives.'
- 6. The Government Order read as 1<sup>st</sup> paper stands modified to this extent.
