## <u>ORDER</u>

The general guidelines on MLA SDF scheme, as modified from time to time have permitted construction of buildings, purchase of audio-visual equipments of educational nature/providing computers and purchase of library books for all Government and Aided Educational Institutions. The PAC in its 25<sup>th</sup> report (2011-14), while making certain recommendations on improvement of implementation of the scheme, suggested Government to stop the practice of allocation of funds to the Aided/Un-aided Educational Institutions under the scheme. After having considered the recommendations of the PAC, Government issued orders in G.O. 2nd cited, to the effect that allocation to Aided Educational Institutions from the fund would be limited to that for providing computers alone. Now suggestions have been received from MLAs to review the above Government Order and to give equal consideration to schools under Government and Aided sector in providing assistance from MLA SDF for developmental activities.

2. Government having reviewed the orders in the Government Order 2<sup>nd</sup> read above are pleased to order that the following items of expenditure relating to aided educational institutions will be allowed to be taken up under the scheme of Special Development Fund for MLAs.

- i. Procurement of computers and computer accessories
- ii. Procurement of equipments for Smart Class Rooms
- iii. Construction of toilets and
- iv. Construction of cooking sheds

3. The Government Order 2<sup>nd</sup> read above will stand modified to this

extent.
