<u>ORDER</u>

The Chief Engineer, LSGD, vide the letter read above, has furnished proposal for declaration of probation of nine Assistant Executive Engineers who were promoted to the cadre of Assistant Executive Engineer vide Govt Orders read above.

The Chief Engineer, LSGD has reported that none of the said Assistant Executive Engineers has availed regular leave during their probation period. It has been certified that the work and conduct of these incumbents are good. No disciplinary action/Vigilance case barring the declaration of probation is pending against these incumbents except Smt. Manju.V.R, against whom MoC/SoA under Rule 15 of KCS (CC&A) Rules vide letter no.114/EW2/2016/LSGD dated 16.10.2021. Since disciplinary action for major penalty is pending against Smt.Manju.V.R, Asst. Exe. Engineer, she is not eligible for probation declaration.

In the above circumstances, the probation of eight Assistant Executive Engineers in the cadre of Assistant Executive Engineer are declared to be satisfactorily completed w.c.f the dates noted against them as mentioned below, as per Rule 20 (b) Part II of KS & SSRs and orders issued accordingly.
