In accordance with the interim order by the Hon'ble Kerala Administrative Tribunal in OA (EKM) No.100/2016, the Promotion of Second Grade Overseers as First Grade Overseer is being done in this department.

Sri. Suresh S D, Second Grade Overseer, Thiruvananthapuram Corporation had not promoted as First Grade Overseer even though his juniors got promotion in the cadre of First Grade Overseer. He was omitted due to want of declaration of his probation in the cadre of Second Grade Overseer. His probation had been declared with effect from 21.05.2008 FN as per order read (4).

Hence Sri. Suresh S D, Second Grade Overseer is provisionally promoted as Draft's Man/Overseer Grade Ist under Rule 31A of the General Rule of KS&SSR 1950 and posted to the office noted against his name.

The above promotion is made in accordance with the judgement in the interim order of the Hon'ble High Court of Kerala Vide OP (KAT) No. 56/2017 and on OP (KAT) No. 71/2017. As per rule 7 (ii) of special rule cited as 1st paper the promote will be on probation for a period of one year on duty within a continuous period of two years from the date of joining duty. This fact may also be noted in the Service Book of the promotee after joining duty in the promotion

post. The Seniority in the promotion cadre will come in to effect from 26.08.2015 onwards. Since his immediate junior Sri. Radhakrishnan T V with Rank No.488 got promoted as First Grade Overseer on 26.08.2015. But the monetary benefits in the promotion post will be effected only from the date of joining duty in the promotion post.
