<u>ORDER</u>

As per the Government Order read as 1st paper above, Government have accredited M/s KAICO to execute Industrial works as PMC under Government departments. However as per reference cited 2nd and 3rd above Government noted that M/s KAICO is executing road works and other building works and that the Estimates for the works are seen prepared by them including Contractors profit and Ovehead charges but without centage charges. Moreover, M/s KAICO is executing civil works through empaneled contractors and without adopting open tender process, which is highly irregular and they have been going the same through Mechanical / Agricultural Engineers. The practice of executing civil works through mechanical engineers and according Technical Sanction for civil works by a committee comprising of such technical persons is highly improper. As per letter read as 4th paper above the Chief Engineer, LSGD has recommended suitable action against M/s KAICO. Government, after having examined the matter in detail, hereby issue orders removing M/s KAICO from the list of Accredited Agencies as shown in the annexure to the GO read as 1^{st} paper above. This will come into effect from the date of this order.
