<u>ORDER</u>

As per G.Os read paper 2^{nd} and 3^{rd} above, Administrative Sanction was issued to the reconstruction of a total of 278 no.s of flood damaged LSGD roads through the LSGD Engineering Wing at a total estimated cost of ₹78.71 crore under RKI.

2. The Chief Engineer LID&EW, as per letter read 4 th above, recommended to drop 17 works worth ₹ 311.85 lakh out of the total works. These works were either completed in other schemes, or failed to get bids even after tender, retender and quotation efforts. The list of these roads are given below;
