The select list for promotion of First Grade Overseers to the post of Assistant Engineers were notified vide reference cited 2nd. In the above circumstances the following First Grade Overseers selected by the DPC held on 22/12/2020 are hereby provisionally promoted as Assistant Engineers under Diploma Quota in the scale of Pay ₹. 39,500/- – 83,000/- by transfer as per provisions contained in the special rule cited 1st and posted to the stations noted against his/her names.

The posting of the incumbents in the promoted stations would not amount to any claim for retaining them in the promoted stations and they are liable to be transferred according to the requests received from the Assistant Engineers at the time of General Transfer.



Three posts in the cadre of Assistant Engineer has been absorbed from the Kozhikkode Development Authority and re-fixed to the cadre strength of this Department vide Ref (4) cited above. Hence the total Cadre Strength of Assistant Engineer of this Department has been raised to 1296. As per the Special Rule cited 5th paper above the ratio among the Direct Recruittees, Diploma Holders and Certificate Holders is 6:3:1 respectively. Hence the Cadre Strength of Assistant Engineer in Direct Quota is 777, Diploma Quota is 389 and Certificate Quota is 130 respectively.

Sri Janardhanan T Assistant Engineer (Certificate Quota) proceeds for Leave Preparatory to Retirement (LPR).

In the above circumstances Ajitha Kumari S (Sl No-1-List A) in the Certificate Quota is



promoted to the post of Assistant Engineer in the vacancy arose due to the absorption of Assistant Engineer posts vide Ref (5) above and Sunil Kumar M B (SI No-2 List A) in the Certificate Quota is promoted to the post of Assistant Engineer in the LPR vacancy of Sri Janardhanan T Assistant Engineer.

The date of promotion of Smt Sairabai P K (SI No-2-List B) in Diploma Quota is reassigned with effect from 05/05/2020.

The date of promotion of Sunil Kumar M B (SI No-2) in the Certificate Quota is reassigned with effect from 15/07/2019.

Smt Shameena V A has been promoted to the post of Assistant Engineer vide Ref (6) cited above. Her name is erroneously entered in the Supplementary Select List-2020 (Diploma Quota).

The juniormost incumbents are liable to be reverted when the superseded senior most officers from the feeder category are qualified for promotion to the post of Assistant Engineer with effect from this/prior date.

The promotees will be on probation for a period of two years on duty within a continuous period of three years from the date of joining duty. During the period of probation he/she should pass the obligatory departmental tests viz. Accountant Test (Lower), Kerala PWD Test and Kerala PWD Manual Tests for completing the probation period in the category of Assistant Engineer. The Controlling Officers concerned are directed to submit their service book to the Accountant General (A&E) Kerala, Branch : Thrissur after recording the joining in the posted station for verification of service.

The controlling officers concerned are directed to relieve the promotees immediately without waiting for the substitutes. The date of joining may be reported in due-course.
