Government accorded Administrative Sanction to the Projects under the Action Plan of Centrally sponsored RGSA Scheme for the Financial Year 2021-22 vide Ref (2) cited above. As per the Ref (1) cited above, it was directed to appoint Assistant Engineers for the Financial Year 2021-22 on temporary basis under the Sub-Plan – Technical Support to Gramapanchayaths of RGSA as per the permission granted for the Financial Year 2020-21.

There are 245 sanctioned posts of Assistant Engineers in the Gramapanchayaths under RGSA Scheme for the Financial Year 2020-21 and was distributed among 10 districts excluding Thiruvananthapuram, Kollam, Kottayam and Eranakulam. As per Letter cited 5<sup>th</sup> paper above it was permitted to continue the RGSA Assistant Engineers appointed in the previous year till 31/03/2022 on the basis of a new agreement.

Accordingly direction have been given to the Executive Engineers concerned to appoint Assistant Engineers under RGSA Scheme vide Ref (7) cited above. As the maximum no of RGSA AEs per Block Panchayat has been limited to two, some Assistant Engineers selected and appointed in the previous financial year has to be accommodated in the other districts. In the above circumstances, the Executive Engineers concerned are hereby directed to accommodate and appoint the Assistant Engineers selected and appointed in the previous financial year but could not be accommodated in their home districts due to the lack of vacancies by executing a fresh agreement till **31/03/2022** as per their request before filling the vacancies in the districts by fresh recruits.
