<u>ORDER</u>

As per G.O. read as 1st paper above, Administrative Sanction was accorded for the reconstruction of 194.63 km of flood damaged Category B (RoW<5mtrs) LSGD roads in seven districts, viz., Ernakulam, Kottayam, Alappuzha, Pathanamthitta, Thrissur, Wayanad and *Idukki* through LSGD Engineering Wing for an estimated amount of ₹67.9 crore.

2. The Chief Engineer, LSGD, proposed the following modifications in the approved list of works;

- i) *Modification of 4 works*: involving change in nature (from tarring to concreting) for 3 works, and revision of estimate of on work from ₹10 lakh to ₹18 lakh.
- ii) Dropping of 14 works: in which 11 works were completed by utilizing various other funds,
 1 work has been proposed under RKI-LSGD-PMU, and the remaining 2 works to be dropped due to non-availability of land.

The Chief Engineer also reported that there shall be an unused amount of ₹3.35 crore from the 14 dropped works, and the proposed cost escalation of ₹8 lakh for one work could be met from this savings amount.

3. Tthe High Level Empowered Committee (HLEC) of the RKI, in its meeting held on 17/05/2021, the minutes of which is read as 2nd paper above, considered the proposal, and approved the same, and directed the RKI to issue revised Administrative Sanction to the same.

4. In these circumstances, the Government are pleased to accord Administrative Sanction for the modifications, dropping of works & revision of estimates as proposed by the CE, LSGD regarding the reconstruction of 194.63 KM of flood damaged Category B (RoW<5mtrs) LSGD roads in seven districts, viz., Ernakulam, Kottayam, Alappuzha, Pathanamthitta, Thrissur,

Wayanad and *Idukki* under the RKI through through LSGD Engineering Wing. The list of approved changes are attached at **Annexure** to this G.O. The Government Order, read as 1st paper above, stands modified to this extent only.
