#### **ORDER**

Administrative Sanction had been accorded for 120 road works under PMGSY-III Batch-I, 2021-22, as per the Government Order read as 1<sup>st</sup> paper above. For 48 works out of these, tender excess had also been sanctioned as per the G.O. read as 4<sup>th</sup> paper above, based on DSoR 2016. Delegation of powers to approve tender excess had been granted to the Departmental Tender Committee headed by the Chief Engineer, KSRRDA, as per the Government Order read as 3<sup>rd</sup> paper above, in



order to avoid delay in awarding PMGSY works with tender excess.

2. Department Tender Committee was held on 23.08.2022 for approving the tender excess for 8 works amounting to ₹3,50,73,574/-. But, the change in Schedule of Rates to DSoR 2018 has necessitated revision of Administrative sanction. As per G.O. read as 6th paper above, revised Administrative sanction for 6 works, which didn't need concurrence of the Finance Department, had been issued. Concurrence of the Finance Department has been obtained for the balance 2 works, as requested by the Chief Engineer, KSRRDA as per the letter read as 5th paper above.

3.In the above circumstances, Government are pleased to accord revised Administrative Sanction for the aforesaid 2 works (listed from Sl. no.7 to 8 in the list of works attached to the letter read as 5th paper above). The details of these 2 works with the original PAC amount (DSR 2016, without GST) and the revised cost as per DSR 2018 (without GST) is attached as annexure. On the basis of this revised AS, the Tender Committee can approve the tender excess in accordance with the powers delegated to the Committee.
