Sub: Directions under section 18 (1) (b) of the water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 for installation of Rendering Plant by slaughter house - Reg.

Sir,

Kind attention is invited to the subject matter. Central Pollution Control Board in exercise of the powers conferred under section 18 (1) (b) of the Water (Prevention and Control of Pollution) Act, 1974 and Air Prevention and Control of Pollution) Act, 1981 directed the State PCB to issue direction to slaughter houses as follows:

1. To install Rendering Plant (dry) along with blood coagulator for processing of animal

2. To install well designed effluent Treatment Plant for treatment of waste water so that the treated effluent comply with the standards prescribed under Environment (P) Act, 1981.

3. To discontinue operation of slaughter house without consent under Water Act 1974 and Air Act, 1981.
