The Controlling Officers concerned are directed to submit their service book to the Accountant General (A&E) Kerala, Branch: Thrissur after recording the joining in the posted station for verification of service. The order of promotion is available in the official website of Chief Engineer, LSGD.

The controlling officers concerned are directed to relieve the promotees immediately without waiting for the substitutes. The date of joining may be reported in due-course.

The newly promoted Assistant Engineers are liable to be transferred according to the request received from the existing Assistant Engineers at the time of General Transfer 2022.
