As per this office order read as 2nd 58 numbers of Second Grade Overseers promoted as First Grade Overseers. Sri Chandran K K Second Grade Overseer, Kozhikkode Corporation has submitted a representation read as 3rd paper above, stating that even though his juniors got promotion in the cadre of First Grade Overseer he was omitted.

On verification of his representation it is noticed that the rank assigned to him in the seniority list of Second Grade Overseers is 409 in between the names of Sri. Babumon P Thottam bearing Rank No 408 and Sri. Raghavan P V bearing Rank No 410. Sri. Chandran K K ,Second Grade Overseer is eligible for promotion to the cadre of First Grade Overseer. Hence Sri. Chandran K K Second Grade Overseer is provisionally promoted as Draught's Man / Overseer Grade Ist under rule 31A of the General Rule of KS & SSR 1950 and posted to the office noted against his name.



As per rule 7 (ii) of special rule cited as 1st paper the promote will be on probation for a period of one year on duty within a continuous period of two years from the date of joining duty. This fact may also be noted in the Service Book of the promotee after joining duty in the promotion post. The incumbent is eligible for notional promotion w.e.f 30.01.2014 since his immediate junior Sri Raghavan with Rank No 410 got promoted as First Grade Overseer on 30.01.2014. The promotion is only notional and the incumbent will not get any monetary benefits.
