As per the judgment vide reference 2<sup>nd</sup> cited, Hon'ble High Court of Kerala has directed the Second respondent (ie the Chief Engineer, LSGD) to consider and pass orders on the representations filed by Smt. Reetha. P.K to include her name in the seniority list of Third Grade Overseers within two months from the date of receipt of copy of judgment. The name of Smt. Reetha. P.K. was not included in the seniority list due to the reason that she had not submitted her option of willingness within the stipulated time limit. In the light of directions from Hon'ble High Court of Kerala, this office records were verified and found that her name was not included in the list of optees to LSGD submitted by the Executive Engineer, District Panchayath, Kozhikkode vide reference 1<sup>st</sup> cited. Hence order was issued by this office vide reference 3<sup>rd</sup> cited rejecting the request of Smt. Reetha. P.K.

The Executive Engineer, District Panchayath. Kozhikkode vide letter under refernce 4<sup>th</sup> cited has informed that Smt. Reetha. P.K had submitted her option in LSGD Section Office but the option is not seen submitted to higher offices from

section office. The Executive Engineer, District Panchayath, Kozhikkode has been directed from this office to conduct an inspection on the matters and to submit a detailed report. As such the Executive Engineer, Kozhikkode reported that Smt. P.K. Reetha submitted options in the section office which is seen countersigned by the Assistant Engineer on 03.01.2008. But the option is not seen submitted to higher offices. The option may be misplaced while processing in the Division Office. Government have been addressed informing the matter and requested further directions regarding the matter. Government have directed vide letter under reference 6<sup>th</sup> cited to include the name of Smt. Reetha. P.K in the appropriate position in the seniority list after issuing notice and obtaining responses of all the affected incumbents as per the rules.

In the above circumstances, it is decided to include the name of Smt. Reetha. P.K in the seniority list of Third Grade Overseers. The incumbent was appointed as Third Grade Overseer in WRD vide advice No. RIA (3) 25525/2001/GW dated 09.11.2011. Hence the seniority of the incumbent in the cadre of Third Grade Overseer may be assigned with effect from 09.11.2011 with rank No. 250 (a) between Sri. Joy Vengilatt and Sri. Sree Hari. G bearing rank Numbers 250 and 251 respectively.

Those who are aggrieved by the provisional inclusion of her name in the seniority list should file their objections with relevant documents within 21 days on the publication of this notice. If no objections are received within stipulated time, the provisional inclusion of the name will be made final.
