Sub:- Fund allotment for 3G data card & office stationary purchase. Ref:- GO (Rt) No. 11012/2015/Fin dated 19/12/2015.

The Government vide GO (Rt) No. 11012/2015/Fin dated 19/12/2015 has allotted \approx 35,71,000/- under various salary heads of LSGD Engineering Wing to meet the stationary expense under 4 Other Items (Non-Plan voted) and for purchasing 3G data card compatible with any SIM & its recurring monthly charges (Max. \approx 250/- per month) for introducing PRICE software in LSGD.

It is advised that fund allotted under information technology will be utilized for purchasing 3G data card at minimum cost. SIM shall be purchased by the respective Engineers from any service providers of their choice depending up on the speed & availability of data connection with in their office premises. The data charge at the rate of ≈ 250 /- per month will be reimbursed depending up on the balance fund available after purchasing data card in the allotted provision or from the next years budget provision. Otherwise, there is already, a G.O. (Rt) No. 2407/2015/LSGD dated 05/08/2015 for reimbursing the data charge from the Grama Panchayaths.

Under the above circumstances all the Executive Engineers are directed to collect and consolidate requirement of data card at the rate of one data card each for one Assistant Engineer of Grama Panchayath, one for each Block Panchayath Assistant Executive Engineer and one for District Panchayath Executive Engineers. The requirement of data card and its minimum cost should be consolidated and submitted to this office before 08/01/2016 itself in the proforma given below.

The Superintending Engineers of North & South Circle should collect the details for Municipalities under their jurisdiction. Superintending Engineers of Municipal Corporation including Kannur should submit the requirement within the specified date itself.

The limited allotted fund available will be disbursed based on the requirement received till 08/01/2016. The requests receive after that will be processed only in the next budget allotment.

The fund available in the minor head 4 Other Items, shall be utilized for purchase of office equipments/stationary as permitted in the minor head (4 Other Items). In the first phase the fund allotted should be primarily distributed to GPs & BPs. The requirement with details shall be submitted before 08/01/2015 by the Executive Engineers.
