CIRCULAR

The Kerala Stamp Act, 1959 of Government of Kerala, clause (g) of serial number 5 says that the stamp duty for an agreement or memorandum of an agreement if otherwise not provided will be one hundred (100) rupees. Govt. have enhanced this to 500 rupees vide The Kerala Finance Bill 2015, (Bill No. 345 of 13th Kerala Legislative Assembly). Later Govt. again reduces this to two hundred (200) rupees via notification No. 5959/Leg A2/2015/Law dated 29.07.2015. As such, the stamp duty for all agreements of public works will be two hundred rupees. This is for information of all the Implementing Officers.

9. Validation. -- (1) Notwithstanding anything contained in the Kerala Provisional Collection of Revenues Act, 1985 (10 of 1985) of in the Kerala Stamp Act, 1959 (17 of 1959) or in the Kerala Value Added Tax Act, 2003 (30 of 2004) or in any other law for the time being in force, during the period commencing on and from the 1st day of April, 2010 to the date of publication of this Act, during which the declared provision contained in the Kerala Finance Bill, 2010 (Biff No. 330 of the XII Kerala Legislative Assembly) were in force anything done or any action taken or any tax or duty collected by virtue of the provisions of the said Bill shall be deemed to have been validly done or taken or collected under the said Acts as if the said amondments had been in force on and from the 1st day of April, 2010 to the date of publication of this Act and no action shall lie against any dealer or authority on the ground of short levy or for refund of excess tax or duty and the tax or duty so collected or paid by a dealer or authority, if any, shall be paid over to the Government.

An Act to consolidate and amend the law relating to stamps in the State of Kerala

WHEREAS it is expedient to consolidate and amend-the law relating to stamps in the State of Kerala:

Be it enacted in the Tenth year of the Republic of India as follows:-

CHAPTER I

PRELIMINARY

I. Short title, extent and commencement:- (1) This Act may be called the Kerala Stamp Act, 1959.

(2) It extends to the whole of the State of Kerala.

(3) It shall come into force on such date as the Government may, by notification in the Gazette appoint.*

2. Definitions.- In this Act, unless the context otherwise requires, (a) "bond" includes—

 (i) any instrument whereby a person obliges himself to pay money to another, on conditions that the obligation shall be void if a specified Act is performed, or is not performed as the case may be;

Preamble.—WHEREAS, it is expedient to give effect to certain financial proposals of the Government of Kerala for the Financial Year 2015-2016;

BE it enacted in the Sixty-sixth Year of the Republic of India as follows:---

1. Short title.---This Act may be called the Kerala Finance Act, 2015.

2. Amendment of Act XII of 1955.—In the Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955), after section 31, the following sections shall be inserted, namely:—
