As per order cited Ist paper above, Sri. Johny J Bosco, First Grade Overseer, Kottarakkara Block Panchayath, Kollam has been promoted as Assistant Engineer and posted at Chengala Grama Panchayath, Kasaragod due to want of vacancies in Southern Districts. Since there is a shortage of Assistant Engineers in Northern Districts especially in Kasaragod district, if the applicant has been transferred from Chengala Grama Panchayath at that time it will adversely affect the on-going implementation of the projects. Hence, the transfer application of the incumbent has kept in abeyance for considering later. Now the applicant filed an OA before the Hon'ble Kerala Administrative Tribunal for getting transfer to Chittumala Block Panchayath, Kollam in the existing vacancy. The Hon'ble Kerala Administrative Tribunal vide order read as paper 3rd above had directed to the 2nd respondent (The Chief Engineer, LSGD) to consider and pass appropriate orders on Annexure A8 representation of the applicant.

In the representation vide paper read as 2nd above, the applicant requested for transfer to Kollam District and stated that his wife is ailing from Thyroid Cancer and she is under treatment in Regional Cancer Center, Thiruvananthapuram. In the meantime, another Assistant Engineer Sri. Najeeb A, Payyoli Municipality, Kozhikkode has requested for getting transfer to Chittumala Block Panchayath, Kollam as he is due to retire from service on 30.04.2019, being a native of Karunagappally, Kollam. At present there is tow vacancies of Assistant Engineers in Kollam District, ie, Chittumala Block Panchayath & Chathannur Grama Panchayath.

The matter has been examined in details, and it is evident that he is eligible for a transfer to his opted district. Sri. Johny J Bosco, Assistant Engineer, Chengala Grama Panchayath, Kasaragod is hereby transferred and posted to Chathannur Grama Panchayath, Ithikkara Block Panchayath, Kollam. The order of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
