<u>Abstract</u>

Local Self Government Department - Engineering Wing - Establishment- Transfer and posting and promotion to the cadre of Assistant Executive Engineer - Orders issued.

<u>ORDER</u>

Special Rules by prescribing the qualification, method of appointment etc, for the post of Assistant Executive Engineer in the LSGD Engineering Wing was issued as per the GO read as Ist paper above. In the above Special Rule, separate ratio for the promotion to the category of Assistant Executive Engineer from among direct recruitees and diploma holders in the feeder category (Assistant Engineer) was not specified. Due to this omission, the seniority list of Assistant Engineers could not be prepared for effecting the promotion. Hence, an amendment was made namely Kerala Local Self Government Engineering Service (amendment) Special Rules 2009 and was notified as per the GO read as 2nd paper above, incorporating the note in Sub rule (1) of rule 3 after category 4 that "promotion to the category of Assistant Executive Engineer shall be made from among direct recruitees and diploma holders in the feeder category in the ratio 3:1".

2. Against the above amendment made in the Special Rule certain employees have moved to the High Court and the WP(C) No. 24284/09 existed at the Hon'ble Kerala High Court in this regard was transferred to the Hon'ble Kerala Administrative Tribunal, Thiruvananthapuram. The Hon'ble Kerala Administrative Tribunal, vide orders dated 28.10.2014 in TA 228/2014 quashed the amendment made to the special rule vide GO read as 2nd above and also the provisional seniority list of Assistant Engineer published by the Chief Engineer, LSGD. The above orders was up held by Hon'ble High Court of Kerala in OP No. 111/15 dated 31.03.2015.

3. However, the Hon'ble Supreme Court of India vide Interim order dated 01/05/2017 on Special Leave Petition (c) No. 16984/2015 had ordered that the "Operation of the impugned order shall remain stayed. Promotion if any may be made as per the rules existing prior to the impugned Judgment. But the same will be subject to the further orders from the Court".

4. According to the above judgment of the Hon'ble Supreme Court of India, order of the Hon'ble Kerala Administrative Tribunal and the Hon'ble High Court of Kerala in quashing the amendment made to the Special Rule vide GO read as 2nd above has became null and void and promotion to the cadre of Assistant Executive Engineer has to be effected by applying the 3:1 ratio between Direct recruitee and Diploma Holders in the feeder category.

5. Total cadre strength of the Assistant Executive Engineers in LSGD is 233. Where the cadre strength of the Assistant Executive Engineers fixed in the ratio of 3:1 among direct

and diploma holders, there should be 175 nos of Assistant Executive Engineers from the direct quota and 58 nos of Assistant Executive Engineers in the diploma quota.

6. At present the Department is having 120 nos of Assistant Executive Engineers from the direct quota and 36 nos of Assistant Executive Engineers from the diploma quota. There is a shortage of 55 nos of Assistant Executive Engineers in the direct quota and 22 nos of Assistant Executive Engineers in the diploma quota, for maintaining 3: 1 ratio in the cadre. At present there are total no. of 76 vacancies of Asst.Exe. Engineers in the department.

7. In the light of the interim order of Hon'ble Supreme Court dated 01.05.2017, the DPC (H) held on 24-10-2017 has decided to prepare select list to the post of Assistant Executive Engineers for the year 2017 based on the ratio 3:1 among direct recruitees and diploma holders. Accordingly, Select List for the year 2017 for promotion to the post of Assistant Executive Engineer has been approved vide GO read as 3rd paper above, by including 55 officials in direct quota and 22 in diploma quota.

8. Under the above circumstances, the following transfer and posting to the cadre of Asst.Exe.Engineers are issued with immediate effect.
