<u>ORDER</u>

As per the GO read as 5th paper above Government have allowed repatriation of 192 ministerial staff from PWD and 44 ministerial staff from Irrigation Department as per the Annexure of that GO to their respective parent Departments subject to condition that their posts will be retained in LSGD for one month from the date of this order so as to give chance for the deployees from PWD and Irrigation to join LSGD.

This time limit will expire on 03-02-2014. And also ordered that after one month the vacancies shall be filled by fresh recruits through Public Service Commission and by promotion.

Government have examined the matter in detail. Since the repatriation of employees will adversely affect the implementation of Plan Schemes at the fag end of financial year Government decided to extend the period up to 31-03-14. Government are pleased to allow repatriation of 192 ministerial staff from PWD and 44 ministerial staff from Irrigation Department as per the Annexure of GO read as 5th paper above to their respective Parent Departments up to 31-03-2014 subject to condition that their posts will be retained in LSGD.

Separate order will be issued regarding the repatriation of deployed employees.
