## PROCEEDINGS OF THE CHIEF ENGINEER, LSGD THIRUVANANTHAPURAM

## ORDER No. E22-1236/2013/CE/LSGD Dated 27.08.2013

Final seniority list of Second Grade Overseers who have opted the LSGD Engineering cadre from PWD and Irrigation Departments and those merged from Municipalities and Corporations, Panchayath Department, Rural Development Board (defunct) etc was finalized and published vide reference cited 1<sup>st</sup>. But the Second Grade Overseers (Juniors) who have been absorbed in the LSGD Engineering cadre from PWD were not included in the final seniority list. Such employees are to be incorporated in the seniority list in the appropriate places by giving their rank based on their seniority as explained in the special rules vide G.O (P) No. 272/2007/LSGD dated 27.11.2007.

I). The provisional seniority list of Second Grade Overseers (Juniors) absorbed from PWD was published in the official website of Chief Engineer, LSGD vide notice reference 3<sup>rd</sup> cited calling for objections regarding the list. Certain representations/objections were received. Giving individual reply is not possible. Hence the objections were verified by the undersigned and clarification/rectification for the objections are as follows:-

There are 78 Second Grade Overseers (junior) from Public Works Department who were absorbed vide reference cited 2<sup>nd</sup>. On scrutiny, out of these 78 Second Grade Overseers (Junior) absorbed in the LSGD Engineering cadre the following overseers have not yet joined duty in this department and hence they are not included in the seniority list.

They have submitted that they were absorbed compulsorily from their parent department without their option or willingness to join LSGD. Hence they have requested to repatriate them to their parent department ie PWD. The incumbents were absorbed from PWD as juniors as found excess in PWD vide G.O. (MS) No.42/10/LSGD dated 04.03.2010. It was the Government decision to absorb these incumbents to this Department. Hence the request of the incumbents cannot be considered and they can't be repatriated to their parent department.

They have submitted that only those persons who have opted LSGD were absorbed in LSGD and is included in the seniority list published in the year 2009 and also stated that the persons who have not opted for LSGD has to be redeployed to the parent department. They are aggrieved by the fact that absorbing the persons who have not opted for LSGD and to include them in the seniority list that too above the applicants and similarly situated persons who had opted for LSGD in the year 2008 will result in grave injustice to those who have opted for LSGD.

As per G.O. (MS) No. 27/08/PWD dated 24.07.2008 PWD transferred among others, 78 numbers of juniormost Second Grade Overseer to LSG Engineering cadre and as per G.O. (MS) No. 42/10/LSGD dated 04.03.2010, Government absorbed 78 number of juniormost Second Grade Overseers shifted from PWD to LSG Engineering cadre. While publication of seniority list of Second Grade Overseers in 2009 it is specified that the seniority list of juniormost Second Grade Overseers absorbed in LSG Engineering cadre will be prepared and published in due course. The second Grade Overseers absorbed as juniors from PWD were not included in the seniority list while publication in 2009, due to the unavailability of details of the incumbents. Hence these Second Grade Overseers (juniors) absorbed from PWD have to be placed in proper positions based on their PSC advice date/date of promotion order. In the above circumstances, there is no illegality in the seniority list of Second Grade Overseers absorbed as juniors from PWD to this department.

On scrutiny of the documents furnished by following Second Grade Overseers, the ranks given through the provisional seniority list are once again verified and corrected according to their merits as specified in the special rules and documents produced by them.
